* Long Term Entry Visa Fee Nok 1300 valid for 5 years.

* Visa transfer fee is 50 Nok.

Additional Charges

The Non-Norwegians and Norwegian nationals born outside Norway is required to pay Nok 100 or 50 (subject to rules) as processing fee, in addition to Visa fee furnished above. Please contact Embassy in this case.

1. Special permission is required for visiting restricted areas like Arunachal Pradesh, Manipur, Mizoram, Nagaland, Sikkim, Parts of Himachal Pradesh, Parts of Jammu & Kashmir and Parts of Rajasthan with additional fees of NOK 100.
2. **For Business visa, enclose a letter of invitation from Indian company/firm and a letter of guarantee from your company /firm.**
3. Completed visa application form must include: **VALID PASSPORT, ONE PASSPORT SIZE PHOTOGRAPH AND APPROPRIATE VISA FEE BY CASH/CHEQUE** (drawn in favour of Embassy of India, Oslo).
4. The Passport should be valid at least another 3 months beyond the date of expiry of visa.
5. Travelling through any yellow fever endemic country, one should possess, a valid yellow fever vaccination certificate before entering into India.
6. **For applying visa by post, please send the visa fee by cash or cheque drawn in favour of Embassy of India, Oslo.** To return the serviced passport by mail, enclose a self-addressed envelope with correct postage stamps under Rek/Registered post. Visa by post is subject to postal delays
7. Nationalities other than Norwegian are requested to contact this Embassy, before submitting their applications. The fees are also different for those who are born in another country but holding Norwegian passport / held another nationality earlier.
8. Sri Lankan Nationals & those who were born in Sri Lanka but holding Norwegian passport must also fill out FAX FORM along with the visa application form.
9. It normally takes 72 hours to obtain visa, in case of ethnic Norwegian nationals.
10. Submission of application : 09:00 – 12:00 Hrs.
11. Delivery of serviced Passports: 16:00 - 17:00 Hrs.
12. For Icelandic citizens, bank clearance & postal charges are extra i.e.
Upto NOK 500/- TM bank charges are NOK 50/- + 80/- NOK Postage
From NOK 501 to 2000/- TM bank charges are NOK 75/- + 80/- NOK Postage
From NOK 2001 onwards TM bank charges are NOK 200/- + 80/- NOK Postage
